Return of Medical Expenses after Loss of Eligibility for National Health Insurance

If you join your employer's health insurance scheme or move out of Ota City, be sure to notify Ota City that you will be leaving the Ota City National Health Insurance program and return the insurance card the city issued to you.

Joining your employer's health insurance scheme or moving out of Ota City will cause you to lose your eligibility for the Ota City National Health Insurance program from the date that you join the other scheme or move out of the city. Consequently, you may no longer use the insurance card for the Ota City program.

If you visit a medical facility using the Ota City program's insurance card without eligibility, you will be required to return the portion of the medical expenses that were covered by Ota City (between 70% and 80% of the total medical expense) and personally make a claim for that portion with your new health insurance scheme.

If you must visit a medical facility before your new insurance card is issued, please consult with the health insurance scheme that is processing your card and notify the medical facility that your card is still being processed.

Please Follow the Waste Disposal Rules

Your household produces waste and recyclables every day. But, even if your intentions are good, could you be sorting it incorrectly? Or are you perhaps sorting it with only a vague idea of the correct way?

Here we look at waste sorting that is often done incorrectly. Please take a moment to reexamine your sorting and disposal of waste and recyclables.

Bulky waste

In general, an item measuring 30 centimeters or more on its side is considered bulky waste. It is still considered bulky waste even if you break it up and put it in a bag.





Differences in material

The disposal method changes depending on the item's materials and the percentages of those materials. Use the disposal method for the material that comprises the largest part of the item.

Take hangers, for example...

Combustible waste



Hangers largely made of plastic or wood

Non-combustible waste



A hanger largely made of metal

Sorting and disposal of bottles

Among recyclables, the sorting of bottles causes considerable confusion.

A bottle's disposal method is determined by the substances (both type and amount) that are in it.

Lids should be disposed of as combustible waste or non-combustible waste, depending on their material.

With food or drink residue

Juice bottles, etc.

Recyclable waste

• Items which can be cleaned easily with water



With oily residue

Bottles for cosmetics, cooking oil, etc.

Non-combustible waste

• Not recyclable even if washed









A little attention to your disposal of waste and recyclables will help keep your neighborhood clean and reduce waste. Please see Ota City's pamphlet if you have questions about the sorting and disposal of waste and recyclables not mentioned above.

Dog Registration and Rabies Vaccinations

- 1 If you are a dog owner, you must comply with the following items in accordance with the Rabies Prevention Act.
- (1) If your dog is at least 91 days old, you must register the dog with the mayor and receive a dog license tag within 30 days of the day that your ownership of the dog began.
- (2) Your dog must be vaccinated against rabies once a year. Furthermore, you must submit a vaccination certificate that was issued by the veterinarian who administered the vaccination to the mayor and receive a vaccination tag.
- (3) You must make sure that the dog license tag and vaccination tag that were issued by the mayor are worn by your dog at all times.

Who All dog owners Where to apply A veterinary clinic near you

The application method varies depending on the veterinary clinic. Check with the veterinary clinic you plan to use to see if you need an appointment.

Important requests to all dog owners!

- Be sure that your dog wears its dog license tag and vaccination tag.
- Always clean up after your dog responsibly.
- Have your dog relieve itself before going on a walk.
- Keep your dog securely on a leash whenever you go out.
- Keep your dog securely on a leash whenever you are in a public park.
- · Keep your dog out of children's parks and playgrounds.
- If your dog bites someone, you must report the bite to a Public Health Center.
- Keep a store of necessary dog supplies on hand in preparation for a disaster or other emergency.
